PRODUCT DESCRIPTION

Pentra-Sil[®] (244+) is a premium Nano-Lithium[®] hardener, densifier and hydrophobic sealer ideal for protecting concrete and masonry surfaces against damage from freeze-thaw cycles, moisture, and chloride ion intrusion.

Pentra-Sil[®] (244+) combines the benefits of Nano-Lithium[®] densification with reactive silicone chemistry to meet the NCHRP 244 standard for chloride protection of concrete in a single application. The reactive treatment reduces permeability and helps prevent efflorescence and spalling. When applied to concrete, it penetrates and reacts with calcium hydroxide to form insoluble calcium silicate hydrate, making the treated concrete more water, stain, and abrasion resistant for easier maintenance and longer life.

This product is not recommended as a "Time of Placement" densifier. Due to the very high solids content of this product, 244+ should not be applied for a minimum of 7 days after the concrete has been placed. The high solids content responsible for this products' unparalleled performance, may react with the high-moisture content in concrete less than seven (7) days old, resulting in white staining if the product is applied sooner than seven days after the concrete is poured.

APPLICATION

Apply only when temperatures will be above 40°F (4°C) for at least 2 hours following application.

Clean surface to remove any dirt, laitance, curing compounds or coatings that may prevent Pentra-Sil[®] (244+) from penetrating. Do not use citrus or acidic cleaners. If acidic or d-limonene cleaners have been used, neutralize the surface using an alkaline cleaner (TSP, Tide laundry detergent, etc.).

Using a sprayer, apply Pentra-Sil[®] (244+) evenly on the surface. Keep the surface wet with product for at least 20 minutes, adding more product where needed.

On newly placed, broom-finished concrete, Pentra-Sil[®] (244+) may be applied seven days following finishing. As the material dries into the surface, spread out any puddles with a soft bristle broom. If curing materials have been applied, it may be necessary to apply Pentra-Sil[®] (244+) at a later time after removing the cure.

On machine-troweled, dyed, acid stained, or integrally colored concrete, after 20-30 minutes of dwell time, use scrubbing equipment with water to rinse the surface and pick up excess material.

The surface is ready for use when dry.

This product is not recommended as a "Time of Placement" densifier. Due to the very high solids content of this product, 244+ should not be applied for a minimum of 7 days after the concrete has been placed. The high solids content responsible for this products' unparalleled performance, may react with the high-moisture content in concrete less than seven (7) days old, resulting in white staining if the product is applied sooner than seven days after the concrete is poured.

*It may be necessary to spray water on hot concrete with a surface temperature above 90°F (32°C) to cool the surface prior to application so Pentra-Sil® (244+) does not flash-dry on the surface. Proceed with product application once the surface is dry.

*Before application, always do a small test sample in a less-visible area to be sure there are no variables or contaminants in the substrate that may be incompatible with this product.

ESTIMATED COVERAGE

Machine-troweled: 600-800 ft² per gallon (14.7-19.6 m² per liter) Broom-finished: 250-350 ft² per gallon (6.1-8.6 m² per liter) *Coverage rate will vary with concrete porosity and environmental conditions.

CLEAN UP

Use soap and water to clean tools and equipment. Although Pentra-Sil® (244+) is nontoxic and environmentally safe, it is alkaline. Use up or dry out extra material and dispose of according to local regulations. Do not pour into sewer systems or storm drains.

Pentra-Sil[®] (244+) will not bridge or fill cracks and will not salvage honeycombed or structurally unsound surfaces. Not suitable for asphalt, non-cement surfaces or painted surfaces. Paint and coatings may be applied over the top of Pentra-Sil[®] (244+).
